**Cleaning Instructions**

The following are our recommended cleaning instructions for Eradi-Lite®:

- Rinse off loose dirt/dust with clean water.
- Mix mild soap/detergent with luke-warm water.
- Wash fabric with above mix using a soft cloth – preferably cotton.
- Rinse with clean water.
- DO NOT pressure-wash. This can damage the fabric.
- DO NOT use harsh chemicals. This could damage the protective acrylic top coat.

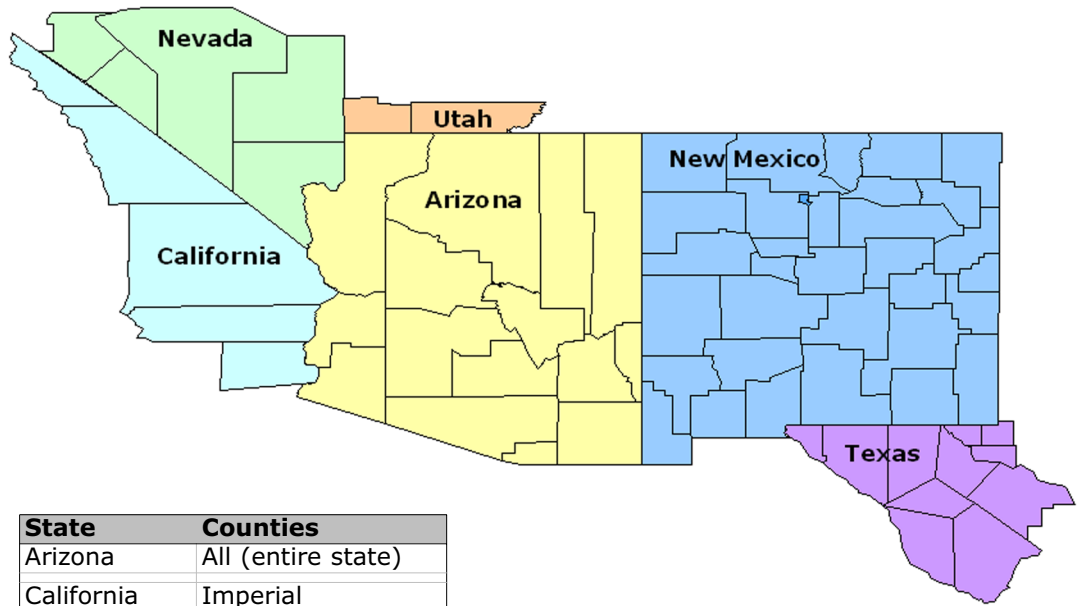
### **Warranty**

Eradi-Lite® is warranted for eight years<sup>†</sup> against loss of color under the following conditions:

- The awning must be properly installed, utilized and maintained. The warranty does not apply against deteriorations of any kind due to abusive use, negligence, vandalism, perforations, or acts of God.
- While all color pigmentations fade eventually, Eradi-Lite® color fastness is guaranteed to remain within the standards set under normal conditions of exposure and atmospheric chemical pollution for a period of eight years from the date of the original installation.
- Normal wear, weather soiling, or stains from environmental pollution or other sources are not covered.
- The warranty, if applicable, is limited to the replacement of the fabric free of charge. Frames, systems, decorations, or labor are not covered by this warranty.
- GLEN RAVEN CUSTOM FABRICS, LLC MAKES NO WARRANTY OF FITNESS FOR ANY PARTICULAR PURPOSES WHATSOEVER WITH RESPECT TO THE GOODS BEING SOLD.
- THERE ARE NO WARRANTIES, EXPRESS OR IMPLIED, WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACE OF THIS AGREEMENT.
- The warranty is valid for eight years from original installation date providing the warranty card is filled out and returned within 30 days of installation to Glen Raven Custom Fabrics, LLC.
- If within the first 60 months of the warranty period Eradi-Lite® fades or undergoes excessive color degradation as described above, Glen Raven Custom Fabrics, LLC will supply to the fabricator sufficient Eradi-Lite® material to produce a new duplicate awning at no charge. If during the last 36 months of the warranty period Eradi-Lite® fades or undergoes excessive color degradation as described above, Glen Raven Custom Fabrics, LLC will supply to the fabricator sufficient Eradi-Lite® material to produce a new duplicate awning at the then current price, and will grant an allowance equal to 1/96th of the original purchase price for each month remaining in the eight year warranted period of use.
- This warranty gives you specific legal rights and you may also have other rights, which vary state to state.
- All claims shall be filed by the fabricator of the awning, through the company that sold Eradi-Lite® to the fabricator.
- New eight year warranty applies to awning projects installed after October 26, 2005.
